

The Village of Nehawka Board of Trustees met in special session on Wednesday, September 24, 2025 at the Nehawka Community Building. Chairman Pro Tem Chad Krueger called the public hearing to order at 7:02 p.m., noted the Open Meetings Act displayed for public viewing, roll call of the board. In attendance: Chad Krueger, Matt Anson, and Ian Begemann. Board Members Pat Neu and Tim Dineen were absent. Other attendees: John Winters (Accountant) and Tom Prickett (Attorney). Purpose of Public Hearing was to hear support, opposition, criticism, suggestions, or observations of taxpayers relating to setting the final tax request at a different amount than the prior year tax request.

Accountant, John Winters handed out and discussed the budget summary, noted the levy limit of 43.4227 cents, discussed the state of the budget, additional spending the previous year, and compared the proposed budget with last year's budget.

As there were no further comments or discussion on the proposed budget or setting the final tax request, the public hearing was adjourned at 7:10pm after a motion made by Begemann and seconded by Krueger. Begemann, Anson, and Krueger were all in favor. Neu and Dineen were absent.

A motion to approve Village of Nehawka Ordinance 2025-7: **AN ORDINANCE TO ADOPT THE BUDGET STATEMENT TO BE TERMED THE ANNUAL APPROPRIATION BILL; TO APPROPRIATE SUMS FOR NECESSARY EXPENSES AND LIABILITIES; TO PROVIDE FOR AN EFFECTIVE DATE** and waive the three readings was made by Begemann and seconded by Krueger. Begemann, Krueger and Anson were all in favor, Neu and Dineen were absent. Motion carried.

A motion to approve Village of Nehawka Ordinance 2025-8: **AN ORDINANCE TO BE ADOPTED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF NEHAWKA, CASS COUNTY, SETTING THE FEE FOR THE ISSUANCE OF A COMMUNICATION TOWER DEVELOPMENT PERMIT AND TO REPEAL ORDINANCES CONTRARY THERETO** and waive the three readings was made by Anson and seconded by Krueger. Begemann, Krueger and Anson were all in favor, Neu and Dineen were absent. Motion carried.
